Dear Member of the General Assembly:

C.R.S. 24-4-103(3)(a.5) directs state agencies to send written or electronic notification to each member of the General Assembly notifying the members of proposed rule-making that increases fees or fines and specifying the amount of the increase of fees and fines. Pursuant to that statute, please allow this letter to serve as notification that on July 15, 2014, the Marijuana Enforcement Division (MED) of the Department of Revenue filed notice with the Colorado Secretary of State to commence permanent rule-making regarding the fees listed below.

In addition, please be advised that the fee changes listed in the rules below became effective on July 1, 2014, pursuant to the emergency rules filed with the Secretary of State on June 30, 2014. A letter was sent on July 8, 2014, to notify members of the General Assembly that MED had promulgated those emergency rules. The proposed permanent rules mirror the currently effective emergency rules.

The majority of the fees that were in place up to July 1, 2014, were aligned more appropriately, resulting in a decrease under the emergency and proposed permanent rules. However, in several instances, the cost of regulatory activities were not being fully met by the fees being charged. As a result, these particular fees increase under the emergency and proposed permanent rules:

Medical and Retail Marijuana Fees

Medical Marijuana Vendor Registration Fee	\$250.00	\$300.00
Medical Marijuana Change of Location Application Fee	\$150.00	\$500.00
Medical Marijuana Occupational Key License Fee	\$250.00	\$300.00
Medical Marijuana Associated Key/Associated Person License Fee (Please note previously, an applicant for this type of license paid \$1,000.00 for the application fee and \$250.00 for the license fee, totaling \$1,250.00. An applicant no longer pays the \$1,000.00 application fee under proposed rules)	\$1,250.00	\$1,300.00
Medical Marijuana Occupational Support License	\$75.00	\$150.00
Retail Marijuana Change of Location Fee	\$150.00	\$500.00
