Program Information >>>

The Pueblo Youth Services Center (PYSC) is a secure twenty-eight bed detention facility operated by the Colorado Division of Youth Corrections (DYC). PYSC serves males and females ages 10-17 years. The facility is located in the Southern region of the state and provides detention services to youth from five judicial districts: the 3rd, 10th, 12th, 15th and 16th Judicial Districts. These districts encompass 16 counties that include: Pueblo, Costilla, Conejos, Mineral, Kiowa, Cheyenne, Baca, Rio Grande, Saguache, Alamosa, Bent, Otero, Huerfano, Prowers, Las Animas, and Crowley.

Youth are detained at Pueblo Youth Services Center pending court hearings for a new criminal charge, or by court order or due to a detention sentence of up to 45 days. Youth participate in 14 hours of programming per day Monday through Friday and 12 hours per day on weekends. Youth attend school Monday through Friday. They engage in recreational activities daily as well as cognitive behavioral programming designed to teach youth skills. Programming focuses upon subjects such as conflict resolution, healthy relationships, parenting, and improved decision making,

Pueblo City Schools provides licensed teaching staff for the comprehensive school program. Youth can generate the credits necessary to receive a diploma or receive a GED (General Equivalency Diploma) while at PYSC.

Pueblo Youth Services Center partners with local community agencies to provide youth an opportunity to give back to their community. Utilizing Restorative Community Justice (RCJ) principles to repair harm and work toward restoring and rebuilding communities, PYC works with local community agencies such as the Caring Pregnancy Center, the Young Women's Christian Association (YWCA), Pueblo County Health Department, Pueblo City Schools, and the Alliance for Healthy Teens. Pueblo Youth Services Center is focused on developing opportunities for victims and community members to become involved in RCJ processes. These opportunities may include serving on impact panels, volunteer occasions, or working with youth and staff in community service projects. By embracing RCJ principles and practices, the program provides youth, victims, and communities the services and opportunities to address the harm experienced and become involved in processes and activities that aid individuals to become increasingly whole. As youth experience these day-to-day restorative applications and services, they develop new skill sets that are used to repair the harm to victims and their communities

Restorative Community Justice >>>

Pueblo Youth Services Center embraces the Restorative Community Justice philosophy, a balanced approach concept that helps repair the harm to victims and/or communities by a juvenile in the custody of DYC.
