

# Colorado Minimum Wage Order Number 35 Fact Sheet

The Colorado Minimum Wage Order Number 35 (7 CCR § 1103-1), effective **January 1, 2019** regulates wages, hours, working conditions, and procedures for certain employers and employees in Colorado. The Wage Order is promulgated by the Division. The Wage Order, in some instances, provides different requirements than FLSA. <p>Applies to private sector employers and employees in Colorado in the following 4 industries:</p> <ol style="list-style-type: none"> <li>Retail and Service</li> <li>Commercial Support Service</li> <li>Food and Beverage</li> <li>Health and Medical</li> </ol> <p>Does not apply to public sector employers.                      Does not apply to independent contractors.                      Does not apply to a variety of other industries such as construction, manufacturing, wholesale.</p>	<p>The time during which an employee is subject to the control of an employer, including all the time when the employee is suffered or permitted to work whether or not required to do so, is compensable work time.</p> <p><b>Travel time</b>                      All travel time spent at the control and direction of the employer, excluding normal home to work travel, is compensable work time.</p> <p><b>Sleep time: 24+ hours tour of duty</b>                      Up to 8 hours of sleeping time can be excluded from compensable work time under certain circumstances.</p> <p><b>Sleep time: Less than 24 hours tour of duty</b>                      Periods during which the employee is permitted to sleep are compensable work time, as long as the employee is on-duty.</p>	<p><i>Contact the Division for more information on the following exemptions:</i></p> <ol style="list-style-type: none"> <li>Administrative</li> <li>Executive/Supervisor</li> <li>Professional</li> <li>Outside sales</li> <li>Domestic employees</li> <li>Companions</li> <li>Casual babysitters</li> <li>Property managers</li> <li>Interstate drivers</li> <li>Driver helpers, loaders, mechanics</li> <li>Taxicab drivers</li> <li>Elected officials</li> <li>Volunteers</li> <li>Interns</li> <li>Prisoners</li> </ol>
MINIMUM WAGE	OVERTIME	ENFORCEMENT
<p>Minimum wage (MW) is <b>\$11.10</b> per hour for all adult employees and emancipated minors.</p> <p><b>Minimum wage credits and exceptions</b></p> <ol style="list-style-type: none"> <li>Up to \$25 per week for lodging furnished by the employer may count toward MW.</li> <li>Reasonable cost of meals provided to the employee may count toward MW.</li> <li>Unemancipated minors under 18 may be paid \$9.44 per hour.</li> <li>Employees with physical disability certified by the Director may be paid \$9.44 per hour.</li> <li>Deductions from wages must be in accordance with the Wage Act.</li> </ol>	<p>In general, non-exempt employees covered by the Wage Order must be paid time and one-half their regular rate of pay for any work in excess of:</p> <ol style="list-style-type: none"> <li>40 hours per workweek;</li> <li>12 hours per workday; or</li> <li>12 consecutive hours without regard to the start and end time of the workday.</li> </ol> <p><b>Exemptions from overtime</b></p> <ol style="list-style-type: none"> <li>Salespersons, parts-persons, and mechanics employed by automobile, truck, or farm implement dealers.</li> <li>Certain commissioned salespersons in retail and service.</li> <li>Certain ski industry employees.</li> <li>Certain medical transportation employees.</li> </ol>	<ul style="list-style-type: none"> <li>The Division has jurisdiction over all questions of fact regarding the Wage Order.</li> <li>Any person may file a written complaint with the Division regarding alleged violations of the Wage Order.</li> <li>Complaints must be filed within 2 years of the alleged violation, except that all actions brought for a willful violation shall be commenced within three (3) years after the cause of action.</li> </ul>
TIPPED EMPLOYEES	MEAL PERIODS	REPRISALS
<ol style="list-style-type: none"> <li>An employee engaged in an occupation where he or she customarily and regularly receives more than \$30 per month in tips is defined as a tipped employee.</li> <li>Employers must pay a wage of at least <b>\$8.08</b> per hour. If tips combined with wages do not equal minimum wage, the employer must make up the difference in cash wages.</li> <li>Employer-required sharing of tips with employees who are not customarily tipped nullifies tip credits toward minimum wage.</li> <li>Deduction of credit card processing fees from tipped employees nullifies tip credits toward minimum wage.</li> </ol>	<ol style="list-style-type: none"> <li>Employees are entitled to an uninterrupted and duty-free 30-minute unpaid meal period when their work shift exceeds 5 consecutive hours.</li> <li>The employee must be completely relieved of all duties for the meal period.</li> <li>If the above conditions are not met, then the employee must be allowed to consume a meal on-duty, and be compensated for the entire on-duty meal period.</li> </ol>	<p>Employers shall not threaten, coerce, or discharge any employee because of participation in any investigation or hearing related to the Minimum Wage Act (C.R.S. § 8-6-101 <i>et seq.</i>)</p>
UNIFORMS	REST PERIODS	DUAL JURISDICTION
<ol style="list-style-type: none"> <li>The employer must pay the cost of the employee uniform if the uniform requires a specific make, logo, or material.</li> <li>Clothing that is considered ordinary street-wear does not constitute a uniform.</li> <li>Employers may require a reasonable deposit up to 50% of the cost of the uniform that must be refunded to the employee upon return.</li> </ol>	<ul style="list-style-type: none"> <li>Employees are entitled to a compensated 10-minute rest period for each 4 hours of work or major fractions thereof. Wages may not be deducted for the rest period.</li> <li>It is not required that the employee be permitted to leave the premises for the rest period.</li> </ul>	<p>Whenever employers are subject to both federal and Colorado law, the law providing the greater protection or benefit for the employee will apply.</p>
