

FOREWORD

This guide has been prepared to help those people with physical limitations enjoy Denver by knowing in advance the facilities which they will encounter. It is, of course, impossible to include all public places in a metropolitan city, therefore, only a representative sampling is given. It is recommended that an advance telephone call be made if there is a special problem or additional information is desired.

Handicaps due to age as well as to specific disabilities were considered in gathering the information. Specific measurements such as width of doorways and number of steps have been listed to aid those in wheelchairs or with leg braces and/or crutches. It is hoped, however, that those who are less severely handicapped, as well as the general public, will also find this guide useful.

THE PROBLEM

"Architectural Barriers" make back-door citizens of millions of persons in wheelchairs, on crutches, with heart and pulmonary conditions, paralysis, and artificial limbs. Across this country, a great number of our citizens, because of physical disabilities, are prevented from using many of our public and private buildings.

Some of these barriers are:

- Lack of proper parking facilities for the disabled.
- Inaccessible entrances with stairs or steep inclines or narrow doorways.
- 3. Restroom facilities without grab bars and not able to accommodate wheelchairs.
- 4. Telephones, because of narrow booth doors or dials too high from floor, unavailable to persons in wheelchairs.

THE SOLUTION

The American Standards Association has prepared certain standards as a guide to make all public buildings and facilities accessible and usable by the disabled, aged and, moreover, the general public.

According to the Journal of American Insurance, September 1964, surveys of buildings that have aids for the disabled indicated a lower incidence of tripping and falling accidents, thus reducing public liability claims, and, accordingly, insurance rates. Fewer accidents in public buildings would also reduce losses and

rates under health insurance plans. As it is much easier to construct buildings without architectural barriers than to eliminate them later, interested citizens can help by urging architects and contractors to consider the specifications prepared by the American Standards Association A177.1.

GENERAL COMMENTS

The guide contains a representative sampling of the public buildings of the Denver metropolitan area. It neither recommends nor endorses any of the facilities listed, but gives a factual statement of conditions as they exist so that each person may determine in advance the availability of that building in relation to his own condition.

Entrances listed are those found to be most accessible by the surveyors for persons confined to wheelchairs. If special assistance is required to enter any building listed, it is recommended that an advance telephone call be made.

Curbs and steps are found only where they are mentioned; otherwise the entrance can be assumed to be ground level.

Addresses given are in the city of Denver unless otherwise designated.

Avenues run east and west, **Streets**, outside of downtown Denver, run north and south and have not been titled.


