Executive Order – Universal Policy:

The State of Colorado has a <u>Universal Policy Pursuant to Executive Order D 023 09 Establishing a</u> <u>Policy to Address Workplace Violence, Including Domestic Violence Affecting the Workplace.</u> The policy will define domestic violence and identify duties and responsibilities of Colorado agencies. You are encouraged to explore your department's policies and procedures.

Relevant Statutes:

Colorado Revised Statute 24-34-402.7 permits an employee to request or take up to three working days of leave from work in any twelve-month period, with or without pay, if the employee is the victim of domestic violence, stalking, sexual assault, or any other crime related to domestic violence.

Colorado Revised Statute 18-6-803.6 requires an arrest of the suspect when the officer determines that there is probable cause to believe that a crime or offense involving domestic violence has occurred.

Executive Order – Universal Policy:

The State of Colorado has a <u>Universal Policy Pursuant to Executive Order D 023 09 Establishing a Policy to Ad dress Workplace Violence, Including Domestic Violence Affecting the Workplace.</u> The policy defines domestic violence and identifies duties and responsibilities of Colorado agencies. We encourage you to explore what your policies and procedures are for your department.

Rights of employees:

Colorado Revised Statutes 24-34-402.7 permits an employee to request or take up to three working days of leave from work in any twelve-month period, with or without pay, if the employee is the victim of domestic violence, stalking, sexual assault, or any other crime related to domestic violence.
