Training Requirements for the Colorado State Model Evaluation System

Any person who conducts an evaluation of school licensed personnel must hold an administrator's license or go through a state approved training program. Because the way educators are evaluated is changing with the passage of Senate Bill 10-191, the need for training on new evaluation expectations and systems is increasing. To support districts in the implementation of S.B. 10-191, the Colorado Department of Education created a model evaluation system as an option for districts. Districts that choose to use the Colorado State Model Evaluation System will need additional training on the technical requirements of the new system.

What Trainings Qualify as a State Approved Program?

There are state approved programs that still meet a portion of evaluator training requirements even with the passage of S.B. 10-91. These include any authorized educator preparation program for administrators and the Colorado Association of School Executives (CASE) series of workshops. However, evaluators must receive additional evaluation training if districts choose to use the Colorado State Model Evaluation System to learn the technical requirements of the new system.

This means that if your school district is using the Colorado State Model Evaluation System in the 2013-14 school year you should complete both an approved supervision and evaluator course (such as CASE or your administration preparation program), <u>and</u> you must attend a CDE training <u>or</u> a session that is led by someone in your district who has been trained in a CDE "train-the-trainer" session. If your district is using its own evaluation system, you should complete an approved supervision and evaluator course, but your district will also be responsible for training you on its unique system (see sidebar).

CDE is using this year (2012-13 school year) to identify the process and criteria that a training program provider will need to meet in the future in order to train on the technical requirements of the Colorado State Model Evaluation System and be a comprehensive and aligned state approved training program in the future. But during this transition, if your district is using the Colorado State Model Evaluation System, you must attend a CDE training (or be trained by someone who received CDE training) to meet the requirements.

What if my district isn't using the Colorado State Model Evaluation System?

- State Board Rules require that all evaluators must be trained in the specific evaluation system that they will be implementing.
- Because Colorado has a model evaluation system, CDE is providing training on the Colorado State Model Evaluation System including the evaluation process, instruments and tools. If your district is implementing a system other than the Colorado State Model Evaluation System, you would not need to attend a CDE training session.
- Your district will train evaluators on the processes, instruments and tools associated with its unique evaluation system.
- In order to receive proper training, you should also go through an administrator preparation program or the CASE Evaluation and Supervision series (see next page for table with additional information).



What Does a CDE Training Include?

The one-day program includes an overview of S.B. 10-191 requirements, the Colorado State Model Evaluation System, the new state Quality Standards for educators, the model rubric, optional measures for the student growth portion of the evaluation and how to train staff. Using the train-the-trainer model, districts may opt to send a few representatives to the one-day CDE training who will then conduct the training for other personnel in his/her district.

How Can I Sign Up for a CDE Training?

The CDE training schedule is being developed in partnership with BOCES. BOCES staff and district administrators will contact districts and identify the appropriate attendees for the CDE trainings so they can be trained and then, in turn, train the rest of their district.
