PREFACE

This bibliography includes references to published information and to publicly accessible file reports, through 1971, concerning the occurrences and characteristics of Colorado's coal resources. It also includes reports pertinent to exploration for and development of Colorado coal resources.

The report is arranged in three sections, the BIBLIOGRAPHY, and two INDEXES. The Bibliography lists publications by the various authors' and coauthors' names in alphabetical order.

The AREA INDEX lists specific reports by the Counties to which they refer if they are not of a regional nature, or by coal Regions where appropriate (see map). These reports are listed without subject designation. The 32 coal-resource counties, and the 8 regions in which they are located, are listed together alphabetically on the lead pages of the Area Index, and are cross-referenced.

The SUBJECT INDEX includes only the general reports of Statewide or broader coverage which are not in the Area Index. These are grouped under fourteen general subject headings.

This bibliography is incidental to the preparation of a summary inventory report on Colorado's coal resources. Data from private sources, which are made available for restricted or unrestricted use in the inventory report, are not listed here.


