NOTE: Laws and regulations in this brochure are paraphrased for easier understanding and are intended only as a guide. Colorado wildlife statutes and regulations are available for viewing at DOW offices.

STATE TRUST LANDS OPEN FOR WILDLIFE RECREATION

Unless otherwise stated in this brochure, these regulations apply to State Trust Lands leased by DOW for wildlife recreation:

- a. Closed March 1-Aug. 31, unless posted otherwise.
- b. Open only to hunting, fishing and wildlife viewing.
- c. Camping prohibited.
- d. Target practice or shooting prohibited.
- e. Youth mentor hunting and/or fishing means hunting or fishing by youths age under 18. Youths under 16 must be accompanied by a mentor. Mentors must be 18 or older, comply with hunter education requirements and accompany youths while hunting.
- f. Closed 1/2 hour after sunset until 1/2 hour before sunrise, unless posted otherwise.

HABITAT STAMP

License Buyers: For License Buyers: A Colorado Wildlife Habitat Stamp is required of people 19-64 who buy hunting or fishing licenses. With a license purchase, the stamp is \$5 and required with the first 2 licenses bought in a calendar year (\$10 total). The stamp allows access to state wildlife areas or state trust lands leased by the DOW. A Habitat Stamp is required of people 19-64 who visit a state wildlife area or state trust land leased by the DOW, such as wildlife viewers or hikers. This stamp is \$10.25 (25-cent search and rescue fee). A lifetime stamp is \$200, which satisfies either of the above requirements.

ADAMS - Jackson Co., GMU 6, Steamboat Spgs. Svc. Ctr.
From Walden, go 4.2 miles N on Hwy. 125 to CR 8. Go 6.8 miles E to CR 8A, then E .8 mile to two-track road. Take two-track .6 mile SE to parking area. Unless accessing from Colorado State Forest, STL provides the only way into Adams and Sand Creek STLs.
ACRES: 3,640 (360 acres in Sections 28, 29, 32, 33, along Sherman Creek, closed.)
OPEN: Aug. 15-Feb. 28.
HUNTING: Elk, deer, pronghorn, moose, small game.

RESTRICTIONS:

- a. Access restricted as posted.
- b. Foot or horseback only.

AGUILAR TV HILL - Las Animas Co., GMU 85, Pueblo Svc. Ctr.
From Aguilar, take Exit 30 off I-25 to CR 63.1. Go .5 mile W.
ACRES: 500
OPEN: Sept. 1-Feb. 28.

HUNTING: Deer, pronghorn, bears, small game.

RESTRICTIONS: Access restricted as posted on E side.

AGATE MOUNTAIN - Park Co., GMU 58, Denver Svc. Ctr.
From Hartsel, go 1.75 miles S on Hwy. 9 to CR 53. Go S 15 miles to parking area on E boundary, S of CR 53.
ACRES: 3,782
OPEN: Sept. 1-Feb. 28.
HUNTING: Big game, small game, wildlife viewing.
RESTRICTIONS: Foot or horseback only.

ALAMADITAS MESA - Conejos Co., GMU 81, Monte Vista Svc. Ctr.
Route #1: From Los Mogotes Peak STL (see directions in this brochure), go W on 2-track 7.5 miles to W boundary. Route #2: From La Jara STL, (see directions in this brochure) go S of La Jara Reservoir on 4WD road to Fox Creek. From Fox Creek, by foot or horseback only, go 1.5 miles S to S boundary to FS land. Go 3 miles E on FS land and cross Fox Creek and Fox Creek trail. Go 1 mile to W boundary.
ACRES: 640
OPEN: Aug. 15-Feb. 28.

HUNTING: Elk, deer, pronghorn, rabbits, grouse, coyotes.
RESTRICTIONS: Motor vehicles prohibited off designated roads.

ALAMOSA CANYON - Conejos Co., GMU 81, Monte Vista Svc. Ctr.
Go 12 miles S of Monte Vista on Hwy. 15; then go 11 miles W on USFS Rd. 250 to Terrace Res. (Alamosa Canyon). Then go on foot or horseback through BLM and national forest.
ACRES: 240
OPEN: Sept. 1-Feb. 28.
HUNTING: Elk, deer, bears, small game.
RESTRICTIONS: Foot or horseback only.

ANTELOPE CREEK - Grand Co., GMU 181, Hot Sulphur Spgs. Svc. Ctr.
From Kremmling, go W 14 miles on Hwy. 40 to Chimney Rock Rd. (USFS Rd. 103), then go 6 miles E to East Carter Mtn. gate. Walk-through gate with signs provides access.
ACRES: 1,240
OPEN: Sept. 1-Feb. 28.
HUNTING: Elk, deer, blue grouse.
RESTRICTIONS:
a. Motor vehicles prohibited off designated roads.
b. ATV, snowmobile access allowed on designated route as posted at East Carter Creek gate during hunting season only.
c. Camping, campfires prohibited.

ANTERO - Park Co., GMU 49/50, Denver Svc. Ctr.
From Fairplay, go S on Hwy. 285 for 16.5 miles. Next to Antero State Wildlife Area. From N of Antero Jct. on Hwy. 24, go 9 miles to Antero Reservoir Rd.; then go W 1.75 miles to NW corner of STL. Or, 4.5 miles N of Antero Jct. on Hwy. 285, then W on unmarked USFS Rd. 433, .5 mile to N boundary. Timber activity may be present.
ACRES: 11,060
OPEN: Aug. 15-Feb. 28. Year-round for fishing.
HUNTING: Big game, small game, waterfowl.

APISHAPA NORTH - Las Animas Co., GMU 133, Pueblo Svc. Ctr.
From Walsenburg, take I-25 exit to Hwy. 10; go E for 18.5 miles. Then go S on CR 77 for 7 miles; go E on CR 90 for 11 miles to Apishapa SWA. Follow signs through SWA to NE side and parking lot.
ACRES: 1,880
OPEN: Sept. 1-Feb. 28.
HUNTING: Deer, pronghorn, bighorn sheep, rabbits, doves, scaled quail, bobcats, coyotes.
RESTRICTIONS:
a. Foot or horseback only.
b. Motor vehicles prohibited past parking lot.

ARROWHEAD - Larimer Co., GMU 19, Fort Collins Svc. Ctr.
From Rustic, go 2.25 miles W on Hwy. 14 in Poudre Canyon, .25 miles on highway frontage on N side.
ACRES: 200
OPEN: Sept. 1-Feb. 28.
HUNTING: Bighorn sheep, deer, elk, rabbits, blue grouse, pine squirrels.

ASPEN RIDGE - Chaffee Co., GMU 57, Salida Svc. Ctr.
From Salida, take CR 175 (Ute Trail) 5 miles N. Turn left on CR 185 and go 5 miles. Access off CR 185 at N and S ends of STL. Timber activity may be present.
ACRES: 542
OPEN: Sept. 1-Feb. 28.
HUNTING: Bighorn sheep, deer, elk.
RESTRICTIONS:
a. Foot or horseback only.
b. Motor vehicles prohibited off designated roads.

ATWOOD - Logan Co. GMU 96, Brush Svc. Ctr.
From Atwood, go 1/2 mile S on Hwy. 63. Access near SE corner of STL next to CR 16.
ACRES: 160

OPEN: Sept. 1-May 31.

HUNTING: Mule deer, white-tailed deer, pheasant, quail, turkeys, ducks, geese, rabbits, squirrels, furbearers.

RESTRICTIONS:

- a. Hunting with centerfire rifles prohibited.
- b. Reservations required for hunting by calling 1-800-846-9453. Reservations not accepted more than 14 days nor less than 48 hours before hunt date. Failing to cancel reservations may result in losing future reservation rights. Max. 1 reservation per day, and 1 reservation per phone call. Reservations not transferable. Person who makes reservation must be licensed hunter and be at property day of hunt. Check in and check out required. For spring turkey reservations for hunters with limited turkey licenses for unit 96, call the DOW's Brush office, (970) 842-6300.
- c. Hunting prohibited except Sat., Sun., Wed., Labor Day, Columbus Day (observed), Veterans Day (observed), Thanksgiving day, Christmas, New Year's, Martin Luther King Day and Presidents' Day.
- d. Four reservations issued per day with a max. of 4 people each. Two reservations are for the general public; 1 for mobility-impaired hunters and 1 for youth and their mentors. The general public and mobility-impaired must hunt on the up river side of Hwy. 63. Youths and mentors must hunt on the down river side of highway.
- e. All recreational activities except deer hunting prohibited on opening weekend of regular plains rifle deer season, and opening day and first weekend of late plains rifle deer season.
- f. Horses prohibited except while training hunting dogs, and then only in Feb., March and April (through Wed. before the opening of spring turkey season).

BACA - Saguache Co., GMU 82, Monte Vista office.

N of Hooper on Hwy. 17, via Rds D and G (E of Hwy. 17).

ACRES: 13,105

OPEN: Sept. 1-Feb. 28.

HUNTING: Elk.

RESTRICTIONS:

- a. Access and hunting allowed through hunt coordinator only. Contact Monte Vista office for reservation, (719) 587-6900.
- b. Hunting restricted to cow elk only.

BADGER CREEK (UPPER, LOWER UNITS) - Fremont, Park Co., GMUs 57/58, Salida Svc. Ctr.

Lower Unit: From Cotopaxi, go 21 miles N on CR 12; then go W 1 mile on BLM road.

Upper Unit: From Hartsel, go S on Hwy. 9 for 1.75 miles to CR 53. Follow CR 53 for 22 miles. Timber activity may be present.

ACRES: 6,032

OPEN: Lower Unit: Year-round for fishing. All other uses, Sept. 1-Feb. 28.

Upper Unit: Oct. 1-Feb. 28.

HUNTING: Deer, elk, bighorn sheep.

FISHING: Coldwater stream.

RESTRICTIONS:

- a. Fishing prohibited on Upper Unit.
- b. Motor vehicles prohibited off designated roads.
- c. Campfires prohibited.

BADGER FLATS - Park Co., GMUs 50 & 581, Denver Svc. Ctr. (GMU 50 N of Hwy. 50, GMU 581 S of Hwy. 50)

Three points of access: (1.) From Lake George, go W on Hwy. 24, 1.5 miles. (2.) From Lake George, go W 2.25 miles on CR 90. (3.) From Lake George, go W on Hwy. 24 about 8 miles to USFS Rd. 891 and go S.

ACRES: 3,570

OPEN: Sept. 1-Feb. 28.

HUNTING: Elk, deer, bears, small game.

RESTRICTIONS: Foot or horseback only.

BAKERS PEAK - Moffat Co., GMUs 3/4, Meeker Svc. Ctr.

In Craig at Hwys. 13 and 40, go N on Hwy. 13 for 24 miles to CR 101. Turn E on CR 101 and go 1.5 miles.

ACRES: 12,393

OPEN: Aug. 1-Feb. 28.
HUNTING: Pronghorn, deer, elk, sage grouse, rabbits and coyotes.
RESTRICTIONS:
a. Foot or horseback only.
b. Motor vehicles prohibited off state or county roads.
c. Camping prohibited.
d. Only portable hunting blinds allowed.

BAKERVILLE - Clear Creek Co., GMU 39, Denver Svc. Ctr.
From Georgetown, take I-70 W 5 miles. STL is 1.25 miles E of Bakerville exit. Majority of ppty. is N of I-70.
ACRES: 320
OPEN: Sept. 1-Feb. 28. Year-round for fishing.
HUNTING: Bighorn sheep, elk, deer, lions, bears, blue grouse, ptarmigan, rabbits, snowshoe hares.
FISHING: Coldwater stream.
RESTRICTIONS:
a. Foot access only.
b. Access only off I-70 right of way.

BALD MOUNTAIN - Moffat Co., GMU 3, Meeker Svc. Ctr.
Tract 1: From Maybell, go N on CR 19 for 15 miles to CR 150. Go W on CR 150 for .5 mile.
Tract 2: From Maybell, go N on CR 19 for 10 miles to CR 71. Go W on CR 71 to CR 71S. Go S on CR 71S for 2.5 miles. Tract 3 & 4: From Maybell, go W on Hwy. 318 for 15 miles to CR 21. Go N on CR 21. Tract 3 is 9 miles N of Hwy. 318 and W of CR. Tract 4 is 14 miles N of Hwy. 318 and on both sides of CR.
ACRES: 6,887
OPEN: Aug. 16-Feb. 28.
HUNTING: Pronghorn, deer, elk, sage grouse, rabbits, small game.
RESTRICTIONS:
a. Campfires prohibited.
b. Motor vehicles prohibited off designated roads.

BEAR GULCH - Custer Co., GMU 69, Salida Svc. Ctr.
From Westcliffe, go 10 miles E on Hwy. 96 to CR 271. Go 1 mile to NW corner of STL.
ACRES: 640
OPEN: From first day of archery deer and elk season through May 31.
HUNTING: Deer, elk, bears, lions, rabbits, squirrels, turkeys.
RESTRICTIONS: Motor vehicles prohibited off designated roads.

BEDDOWS MOUNTAIN - Custer Co., GMU 691, Pueblo Svc. Ctr.
From Westcliffe, go N about 8 miles on Hwy. 69. Parking off Hwy. 69.
ACRES: 500
OPEN: From first day of archery deer and elk season through May 31.
HUNTING: Deer, elk, bears, lions, turkeys, rabbits, squirrels.
RESTRICTIONS:
a. Foot or horseback only.
b. Parking prohibited on Hwy. 69.
c. Shooting prohibited within 500 feet of Hwy. 69 and man-made structures.

BEN MORGAN CANYON - Moffat Co., GMU 211, Meeker Svc. Ctr.
From Meeker, go 23 miles N on Hwy. 13. Turn W on CR 17 to CR 32. Go W 11 miles to CR 55. Go 2.5 miles to parking lot.
ACRES: 640
OPEN: Sept. 1-Feb. 28.
HUNTING: Deer, elk, pronghorn, small game.

BERRY CREEK - Eagle Co., GMU 36, Glenwood Spgs. Svc. Ctr.
From Vail, take I-70 W to Exit 163 (Edwards). Go N to Singletree entrance, then W to USFS Rd. 778. Go 1 mile and take first left after cattle guard. Go 2.5 miles. Several 4-WD roads run

through STL. Surrounded by USFS land.

ACRES: 640

OPEN: Sept. 1-Feb. 28.

HUNTING: Deer, elk, bears, blue grouse, rabbits, coyotes.

BIG HOLE GULCH - Moffat Co., GMU 3, Meeker Svc. Ctr.

From Craig, go 40 miles N on Hwy. 13. Take CR 4 W 15 miles.

ACRES: 1,847

OPEN: Aug. 15-Feb 28 for hunting. Year-round for fishing.

HUNTING: Pronghorn, deer, elk, small game.

RESTRICTIONS:

- a. Camping, campfires prohibited.
- b. Only portable hunting blinds allowed.

BLACK HAWK - Huerfano Co., GMU 85, Pueblo Svc. Ctr.

From Walsenburg, go S on I-25 to Exit 42. Take CR 310 to Pryor; then go 2.5 miles S on CR 312 to E side of STL. Or, take CR 310 W to N side.

ACRES: 1,511

OPEN: Sept. 1-May 31.

HUNTING: Deer, bears, lions, pronghorn, elk, doves, rabbits, turkeys.

RESTRICTIONS:

- a. Foot or horseback only.
- b. Motor vehicles prohibited off county roads.

BLACK MOUNTAIN - Huerfano Co., GMU 84, Pueblo Svc. Ctr.

From Gardner, go 1 mile W on Hwy. 69. Turn N on USFS Rd. 634 and go 6 miles to USFS Rd. 635 (Black Mountain Rd.) Go W .5 mile to access markers.

ACRES: 640

OPEN: Sept. 1-May 31.

HUNTING: Deer, elk, rabbits, squirrels, doves, coyotes, turkeys.

RESTRICTIONS: Foot or horseback only.

BLACK SAGE PASS - Gunnison Co., GMU 551, Gunnison Svc. Ctr.

From Gunnison at Hwy. 50 and USFS Rd. 243 (Marshall Pass Rd.), go N on Hwy. 50 for 1 mile to USFS Rd. 888. Go N on USFS Rd. 888 for 5.5 miles to S boundary.

ACRES: 415

OPEN: Sept. 1-Feb. 28. Year-round for fishing.

HUNTING: Deer, elk, bears, lions, blue grouse, rabbits.

FISHING: In small section of No Name Creek.

RESTRICTIONS: Foot or horseback only.

BLUE LAKE - Bent Co, GMU 125, Lamar Svc. Ctr.

From Las Animas, take Hwy. 194 W to CR 10; go N 11 miles. On CR TT, go W 2.5 miles to E boundary. There are several parking lots: (1) at end of CR TT; (2) at bridge on SE corner; (3) at S end.

ACRES: 14,059

OPEN: Year-round.

HUNTING: Pronghorn, deer, waterfowl, upland game.

FISHING: Warmwater lake.

RESTRICTIONS:

- a. Islands closed May 15-Aug. 31.
- b. Camping permitted as posted.
- c. Motor vehicles permitted on designated roads only.

BLUE SPRING - Huerfano Co., GMU 84, Pueblo Svc. Ctr.

From Gardner, go W on Hwy. 69 for 1 mile to USFS Rd. 634. Turn N and go 13 miles.

ACRES: 640

OPEN: Aug. 15-May 31.

HUNTING: Deer, elk, lions, small game.

RESTRICTIONS:

- a. Hunting prohibited in safety zone along E boundary as posted.
- b. Foot or horseback only.

BOSTON FLATS - Moffat Co. GMU 3, Meeker Svc. Ctr.

From Maybell, go NW 3.5 miles on Hwy. 318. STL N of Hwy. 318. Parking between highway and STL. No roads; only walk-in access.

ACRES: 104

OPEN: Year-round for fishing, watchable wildlife. Sept. 1-Feb. 28 for hunting.

HUNTING: Big game, small game.

RESTRICTIONS: Foot access only.

BOX CREEK - Lake Co., GMU 48, Salida Svc. Ctr.

From Leadville, go 7 miles S on Hwy. 24, turn W on CRs 10 and 24 for 2.4 miles.

ACRES: 629

OPEN: Sept. 1-Feb. 28.

HUNTING: Elk, deer, small game.

RESTRICTIONS: Foot access only.

BOX ELDER - Moffat Co., GMU 211, Meeker Svc. Ctr.

From Hamilton, go S on Hwy. 13 for 11 miles to CR 17. Turn right, and go 1.5 miles to CR 51. Go 1 mile to CR 32, and go 8.5 miles to BLM access.

ACRES: 628

OPEN: Sept. 1-Feb. 28.

HUNTING: Big game, small game.

RESTRICTIONS: Foot or horseback only.

BOX ELDER NORTH - Moffat Co., GMU 211, Meeker Svc. Ctr.

From Meeker, go 23 miles N on Hwy. 13. Turn W on CR 32, and go W 7 miles to parking lot.

ACRES: 640

OPEN: Sept. 1-Feb. 28.

HUNTING: Deer, elk, pronghorn, small game.

BRAVO - Logan Co., GMU 91, Brush Svc. Ctr.

From Sterling, take Hwy. 6 E about 2 miles to CR 37. Go N on CR 37 for 5.7 miles.

ACRES: 80

OPEN: Sept. 1-Feb. 28.

HUNTING: Deer, waterfowl, small game.

RESTRICTIONS: Access from designated parking areas only.

BULL MOUNTAIN - Larimer Co., GMU 8, Fort Collins Svc. Ctr.

From Fort Collins, take Hwy. 287 N 22 miles to Cherokee Park Rd. (CR 80C). Go 35 miles W. CR 80C runs through SE corner. Two-track road runs into SW part.

ACRES: 640

OPEN: Sept. 1-Feb. 28.

HUNTING: Big game, small game.

RESTRICTIONS:

- a. Foot or horseback only.
- b. Motor vehicles prohibited off county roads.

BURRO SPRINGS 1 & 2 - Saguache Co., GMU 68, Monte Vista Svc. Ctr.

From LaGarita, go N on CR 42 for 2.2 miles to CR 42K. Go W on CR 42K.

ACRES: 6,175

OPEN: Aug. 15-May 31.

HUNTING: Elk, deer, pronghorn, bighorn sheep, lions, rabbits, doves, blue grouse.

RESTRICTIONS: Motor vehicles prohibited off designated roads.

CARNERO - Saguache Co., GMU 68, Monte Vista Svc. Ctr.

From La Garita, go 4 miles west on CR 41G.

ACRES: 1,714

OPEN: Sept. 1-Feb. 28.

HUNTING: Elk, deer, bighorn sheep, bears, lions, small game.

RESTRICTIONS: Foot or horseback only.

CARR TRACT - Weld Co., GMU 87, Fort Collins Svc. Ctr.

From Fort Collins, take I-25 N 20 miles to Carr exit. Go E on 2 miles to CRs 126 and 17.

Access 1: 0.5 miles N of CR 126 on CR 17. Access 2: N of CR 126 at SE corner of STL, about 4 miles E of CR 17 (2.5 miles E of town of Carr).

ACRES: 3,133

OPEN: Access restricted to pronghorn hunting only during pronghorn seasons.

HUNTING: Pronghorn. Caution: bison may be present.

RESTRICTIONS:

- a. Hunting from blinds prohibited.
- b. Fires prohibited including, but not limited to, open fires, BBQ's, sterno cans, stoves, smoking.
- c. Access by permit holders and 1 non-hunting companion. Maximum of 10, one-day access permits issued daily by DOW. Permits available beginning Aug. 1. Contact DOW in Fort Collins, (970) 472-4300.
- d. Parking allowed only for permit holders in designated areas.

CARTER CREEK - Grand Co., GMU 181, Hot Sulphur Spgs. Svc. Ctr.

From Kremmling, go 14 miles W on Hwy. 40 to Chimney Rock Rd. (USFS Rd. 103); go 3 miles E to parking area and sign.

ACRES: 1,301

OPEN: Sept. 1-Feb. 28.

HUNTING: Deer, elk, blue grouse, sage grouse.

RESTRICTIONS:
